Submitting P11D and P11D(b) forms

IMPORTANT!

From 6th April 2023, HMRC will no longer accept paper copies of P11D and P11D(b) forms. For the 2022/2023 reporting year, all P11D and P11D(b) forms must be submitted online. This means that you will not be able to send the paper forms produced in IRIS P11D directly to HMRC.

Car and Car Benefit Changes

- The appropriate percentage will increase for cars registered on or after 6 April 2020 with an approved CO2 emissions figure by one percent, to a maximum rate of 37%.
- The appropriate percentage will increase for cars with zero emissions registered after 1 January 1998 but before 6 April 2020 to 1% for fuel type A and F. Fuel type D will continue to incur a surcharge of +4%.
- The Car Fuel Benefit will increase from £24,600 to £25,300.

Official Rate of Interest

The official rate of interest for loans and accommodation is 2% for 2022/2023.
