iXBRL is a technology developed for HMRC that retains the structure of the documents being submitted; the result is machine readable XBRL data that retains the original human-readable formatting. To achieve this, certain elements of the tax computation and the accounts 'documents' will need to be tagged. HMRC identified close to 1,300 individual elements that required analysis and tagging from the April 2011 introduction.

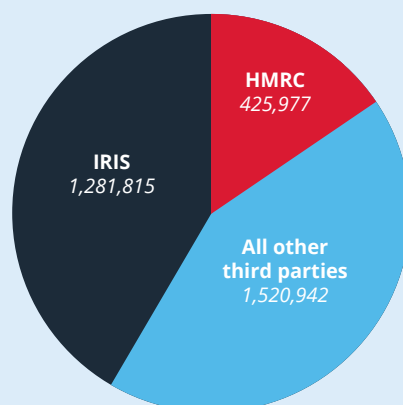
