Auto enrolment affects every business in the UK. With over half a million small businesses staging this financial year alone, it's important to prepare early, as Home Farm have done.

Recommendations

Automatic Enrolment

The Workplace Pension Reforms will impact every single business in the UK that employs someone. We started by asking Penny what her first thoughts were when the legislation was announced. She told us "When auto enrolment was first announced, I had mixed thoughts. If you're younger then it's good because you're saving for your future, something younger people don't necessarily think about. For businesses it does mean a lot more work and preparation, I also think it's slightly over-complicated, but overall it's a good thing if it gets people saving."

Training for the Legislation

Home Farm are yet to reach their staging date, but in preparation for January 2017, Penny explained how she started to get ready for the legislation's introduction. "We first started preparing for auto enrolment a long time in advance, my predecessor introduced me to her work on it and I started 18 months ago, so the farm would have started its preparations around two years ago," she explained.

It's recommended that businesses begin their preparations for automatic enrolment at least 12 months in advance, as it is often more time consuming to get ready for than businesses think.

Manual vs. Automatic?

The Pensions Regulator themselves recommend that businesses of any size manage their workplace pension commitments through payroll software, rather than manually. It's rare that we come across businesses who do plan to manually process everything, but it does happen. Penny had no such plans, telling us that, "I plan to manage auto enrolment through the software rather than manually. Using the software means it's quicker and also leaves a trail behind.

Contacting IRIS

There will be times when you need to get in touch, we've invested heavily in our Sales and Support teams, and this shows. Penny explained that "the Sales and Support departments at IRIS have really helped me through the preparations for auto enrolment.
