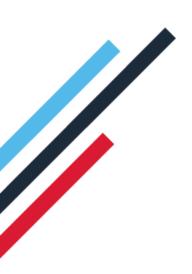

- At the click of a button IRIS Payroll Professional will contact the HMRC Gateway and verify the tax status for any of the sub-contractors on the system
- Material and Labour costs can be split between different jobs (Requires the costing module to be purchased)
- Calculates VAT for VAT registered sub-contractors
