We have updated all relevant forms and Working Sheets for the 2020/2021 tax year. The vehicle database has also been updated.

Car and Car Benefit Changes

- The appropriate percentage will increase for Cars registered on or after 1 January 1998 without an approved CO2 emissions figure to 24% for engine size 0 – 1400 and to 35% for engine size 1401- 2000. Over 2001 and rotary engines will remain at 37%
- The appropriate percentage will increase to a maximum of 37% for Company Cars with fuel type D and which have been registered on or after 1 January 1998 without an approved CO2 emissions figure
- The appropriate percentage will increase for all Cars registered before 1 January 1998 to 24% for engine size 0 – 1400 and to 35% for engine size 1401 – 2000. Over 2001 and rotary engines will remain at 37%
- The appropriate percentage for cars with approved CO2 emissions will be set based on whether the car was registered before or after 6th April 2020
- The Car Fuel Benefit will increase from £24,100 to £24,500
